16) Brief facts of the case:

It was alleged in the complaint lodged by Sri P. Murali Krishna, the then GM (Procurement) that TTD has received various complaints regarding quality of laddu prasadam. Hence, the suppliers were warned to improve the quality of Ghee. It is further alleged that all the firms improved their quality of Ghee, except M/s A R Dairy Food Private Limited (A-1) Dindigul. TTD floated e-tender on 12.03.2024 for supply of 10 lakh kgs of Cow ghee within 1500 kms of radius from Tirumala. The tender was finalized on 08.05.2024 and supply order was issued on 15.05.2024 in favour of M/s A R Dairy Food Private Limited (A-1) Dindigul @ Rs.319.80 per kg cow ghee. It is further alleged that prima facie the price of Rs.319.80 per Kg appeared to be unviable and unreasonable for supplying pure Ghee. M/s A R Dairy Food Private Limited (A-1), Dindigul supplied 4 tankers on 12.06.2024, 20.06.2024, 25.06.2024 and 04.07.2024 respectively, and the same were accepted with earlier procedure of testing which doesn't include adulteration testing in TTD lab. The samples were drawn from 2 tankers on 06.07.2024 and 2 tankers on 12.07.2024 and forwarded to NDDDB CALF Lab. TTD received the NDDDB CALF Test Reports on 16.07.24 and 23.07.24 respectively which shows ghee adulteration with vegetable and animal fats. Thus, M/s A R Dairy Food Private Limited (A-1), Dindigul by supplying
